Application for grant of Licence (1) An application for the grant of the license shall be made to the Federal government through the Director General, in (triplicate), in Form 2, together with a certificate of character from the District Magistrate or any other person authorized by the Federal Government in this behalf, and non refundable application fee of <u>[Five thousand] rupees</u></p> | <p>In rule 8, sub rule 1 after the words, "and non refundable application fee of" the words "five thousand rupees" shall be replaced by the words "<u>Fifty Thousand rupees</u>".</p> | |

| Rule-9. Renewal of Licence | | |
| (1) A license granted under rule 8 shall be valid for three consecutive calendar year or part thereof and may be renewed by the Director-General under sub-rule (2) on an application made in that behalf to him in Form 3, through the Protector of Emigrants, at least one month before its expiry and on payment of renewal fee of [fifteen thousand] rupees per annum, after a demand notice has been issued by the Director General: | In rule 9 sub-rule 1 after the words, "payment of renewal fee of", the words " Fifteen thousand rupees " shall be replaced by the words " fifty thousand rupees ". | |
| 2(c) For a period of one year, if the licensee has sent no worker or less than ten workers for employment abroad within the last three years of the validity of the license. | 2(c) For a period of one year, if the licensee has sent " Fifty or less workers for employment abroad within the last three years of the validity of the license. | |

| An Overseas Employment Promoter shall establish an office in the premises approved by the Federal Government. He shall not shift his office or open more than two branch offices or shift the same except with the prior permission of the Federal Government and on payment of fee five thousand rupees.] | An Overseas Employment Promoter shall establish an office in the premises approved by the Federal Government.
