However, all candidates shall be elected by simple majority, jointly by the Corporate class, Associate class members and Women members of Executive committee.</p> <p>(VI) Holding of Polling for Elections of Office Bearers through secret ballot.</p> <p>(VII) Complete and proper record of draw and elections shall be maintained and shall be kept under safe custody of Secretary General.</p>
