As per Election Commission findings under, sub rule (6) Rule-18 following voters have been removed from Provisional voters list 2021-22. However the following members & including those members which were already removed in the decision by Secretary General, due to non-provision of the evidence of filing income tax return for the preceding year 2020, will be eligible to their votes subject to the provision of proof of filing of income tax return for the year 2020, before the date of display of final list of voters 2021. Furthermore, the complaints which were not completing one year of their re-enrollment till the announcement of election schedule are ineligible to vote in Elections 2021, the list of such ineligible voters is already published in decision by the Secretary General dated 30th July 2021.
