Chairman had given the briefing over the meeting held in Saudi Consulate Islamabad 24th Nov and the commitments which were made in the meeting were unfortunately not filled due to change of the Head of the consulate section, he told the members that after the appointment of the new Head of consulate section we have submitted multiple requests for providing an appointment via official letters but still there was no response on the correspondences. Chairman had told the members that the Honorable Ambassador is visiting FPCCI on 15th Feb 2021, but due to my commitment with the SAPM and DG bureau meeting, I wasn't able to meet him, but I have assigned responsibility of Mr. Syed Khalid Jamal (Executive member) to meet him at the meeting of FPCCI and will submit a request letter for meeting at any suitable time convenient to his excellency. Further he has assured that we have high hopes after having a meeting with the ambassador, most of the hurdles and issues related to visa endorsement will be streamlined.

Moreover the Chairman briefed the committee that the Karachi Consulate is functioning smoothly, only the issuance of User-ID & passwords is delayed due to absence of IT department staff, and the department is not properly functional, as soon as the department is properly functional this only remaining issue will be sorted out properly.

#### **Decision:**

A unanimous decision by the executive committee is to formulate a proper plan of activities to resolve & handle the issues related to Islamabad Embassy, Plan –A would be a meeting with the Ambassador and Plan-B is to correspondence through Ministry of Op & HRD and commencement of a joint meeting in the supervision of SAPM. After taking all the measures, the OEP community would have no other way then to protest against all the in justification against the manpower promotion sector.

Agenda No.3 Status regarding proposed amendments in Emigration Rules 1979 & POEPA reservations recorded for new proposed insertions by the Ministry of OP & HRD.

The Chairman had briefed that the proposed amendments in Emigration Rules 1979 is pending for the approval of the Ministry OP & HRD. We were informed by Bureau of the several changes inserted by the Ministry, all of our proposals in those insertions were remains unnoticed except service charges enhancement up to Rs. 20,000 whereas, some of the new insertions were proposed those are totally unacceptable and were against the competition act, therefore we have recorded our reservations through a letter to DG Bureau and also requested an urgent meeting with the D.G Bureau and Ministry official to inculcate better and mutually agreed amendments in favor of both the OEP community and Pakistani workforce. For this purpose DG bureau of Emigration had committed to convene a meeting with the SAPM & Federal Secretary in coming days to finalize the proposed amendments and record our reservation upon the new insertions.

Further, the press conference is appreciated but had not brought any fruitful results, but actually had wasted time and money.
